

- New and existing Home Care Package clients of Catholic Healthcare Limited (ABN 69 064 946 318 22) (**Catholic Healthcare**) are eligible to enter a draw to win one of three Flight Centre Gift Cards worth \$5,000, \$3,000 and \$2,000 respectively (**Prizes**).
